

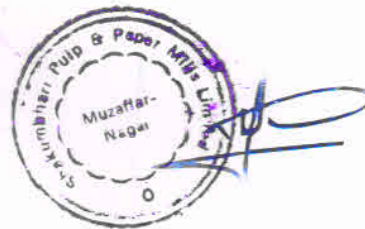


It has been my privilege to serve on the Board of Directors of the Company and I thank you for the co-operation extended during my tenure.
